## NOTICE OF LIQUIDATION AND FIRST AMENDED DEADLINE TO FILE CLAIM

TO ALL CLAIMANTS HAVING CLAIMS AGAINST THE ESTATE OF CAMERON MUTUAL INSURANCE COMPANY ("CMIC"). PLEASE REVIEW THIS NOTICE CAREFULLY, AS IT SETS OUT IMPORTANT INFORMATION CONCERNING YOUR RIGHTS AND RESPONSIBILITIES AS A POTENTIAL CLAIMANT.

Effective December 1, 2023, the Circuit Court of Cole County, Missouri, ordered that CMIC be liquidated and that all remaining distributable assets of CMIC be distributed to approved claimants of record. <u>Instructions for Policyholders with an Insurance Claim</u>: Policyholders may submit an insurance claim by phone, email, or fax. Policyholders do not need to file a separate Proof of Claim unless they believe their claim may exceed or be outside of Guaranty Association coverage limits of \$300,000 in Missouri and Arkansas and \$500,000 in Iowa. All policy claims against CMIC must be reported by phone, postmarked, or sent electronically by <u>December 31, 2024</u>.
